Claims Army Is Stacking Courts Martial

Indiana Senator
Lays Protest
Before Patterson

Washington, July 8 (AP)—Senator Jenner (R-Ind.) contended today that "the high command in the European theatre is stacking courts against defendants in court martial."

In a letter to Secretary of War Patterson demanding a full investigation of army military trial procedure, Jenner offered what he said was documentary proof that:

1. "Prisoners are not being permitted to employ either civilian or military counsel of their own choice in the preparation and presentation of their defense."

2. "Every effort is being made to prevent attorneys who were connected with the infamous Lichfield prison case to practice in courts martial in the European theatre."

The Indiana senator made public a copy of an informal "routing slip" which he said was signed by Brig. Gen. Cornelius E. Ryan, assistant deputy, military government headquarters for the military government for Germany, and written by Col. Francis H. Venderwerker. Jenner told newsmen that the routing slip substantiated his charges.

The slip, addressed to the chief of staff, USFET (presumably US forces, European theatre), was dated last Oct. 23.

RAAF Captures Flying Saucer On Ranch in Roswell Region

House Passes Tax Slash by Large Margin

Defeat Amendment
By Demos to Remove
Many from Rolls

Washington, July 8 (AP)—The house passed today the Republican-backed bill to cut income taxes by \$4,000,000,000 annually for 49,000,000 taxpayers, beginning Jan. 1.

It goes to the senate where approval also is forecast.

The vote was 362 to 11, or more than the two-thirds majority needed to override a presidential veto.

The action, which may encounter another presidential veto, came after Speaker Martin (R-Mass.) personally appeal to the house to pass the bill by such a decisive vote—as to persuade the president that the people should have this delayed justice.

The measure is identical with one passed by President Truman

Security Council Paves Way to Talks On Arms Reductions

Lake Success, July 8 (AP)—The United Nations security council today approved an American blueprint for arms reduction discussions despite a Russian warning that the plan would bring about a collapse of arms regulation efforts.

The vote was 9 to 0, with Russian and Poland abstaining.

In view of Russia's firm stand against the U. S. plan it had been believed she might invoke the big power veto to block it.

Soviet Deputy Foreign Minister Andrei A. Gromyko gave his warning before the United Nations security council in a new effort to revive the Soviet working plan which already had been rejected by the commission for conventional armaments.

His challenge was taken up promptly by French delegate Alexandre Parodi and U. S. Representative Herschel V. Johnson, who announced their opposition to any substitute for the American plan.

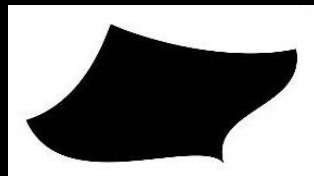
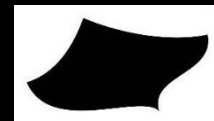
AAF CAPTURES FLYING SAUCER ON RANCH IN ROSWELL REGION

from the crash site $\frac{3}{4}$ mile, for 3 years

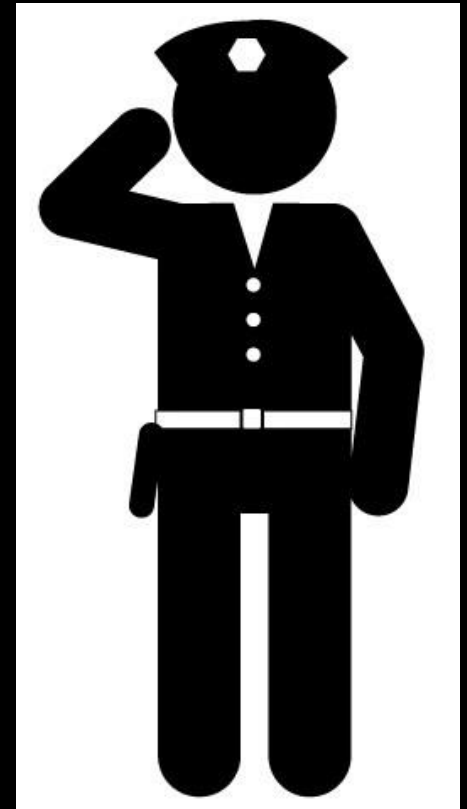
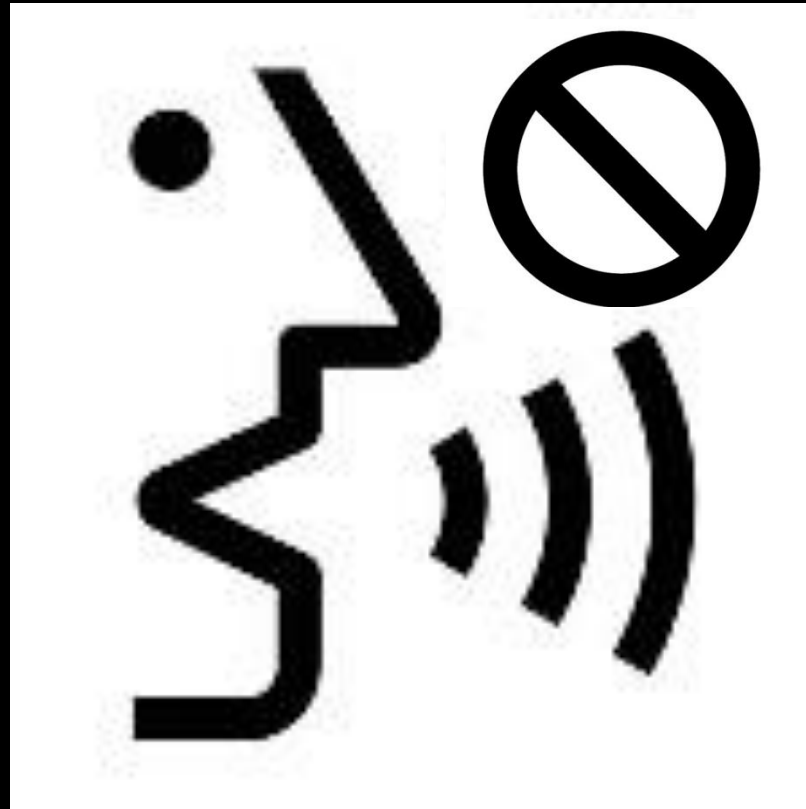
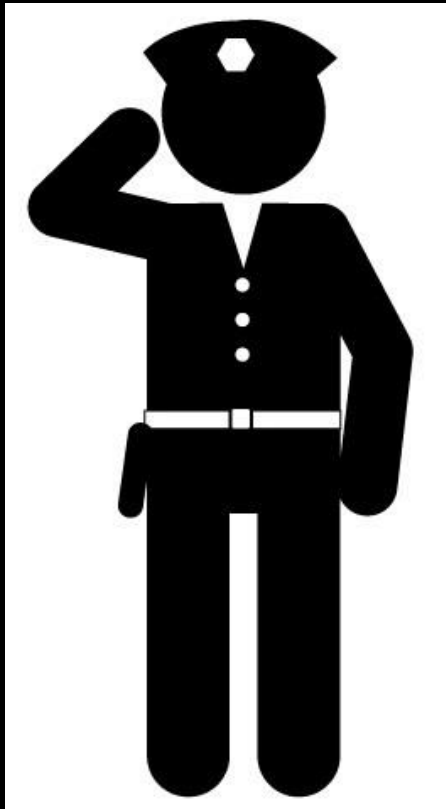


All evidence at the crash site was collected and sent to a hanger at the air force research facility indestructible “memory metal”

A US Senator called the local radio station to stop any reporting of a UFO or lose their license that day



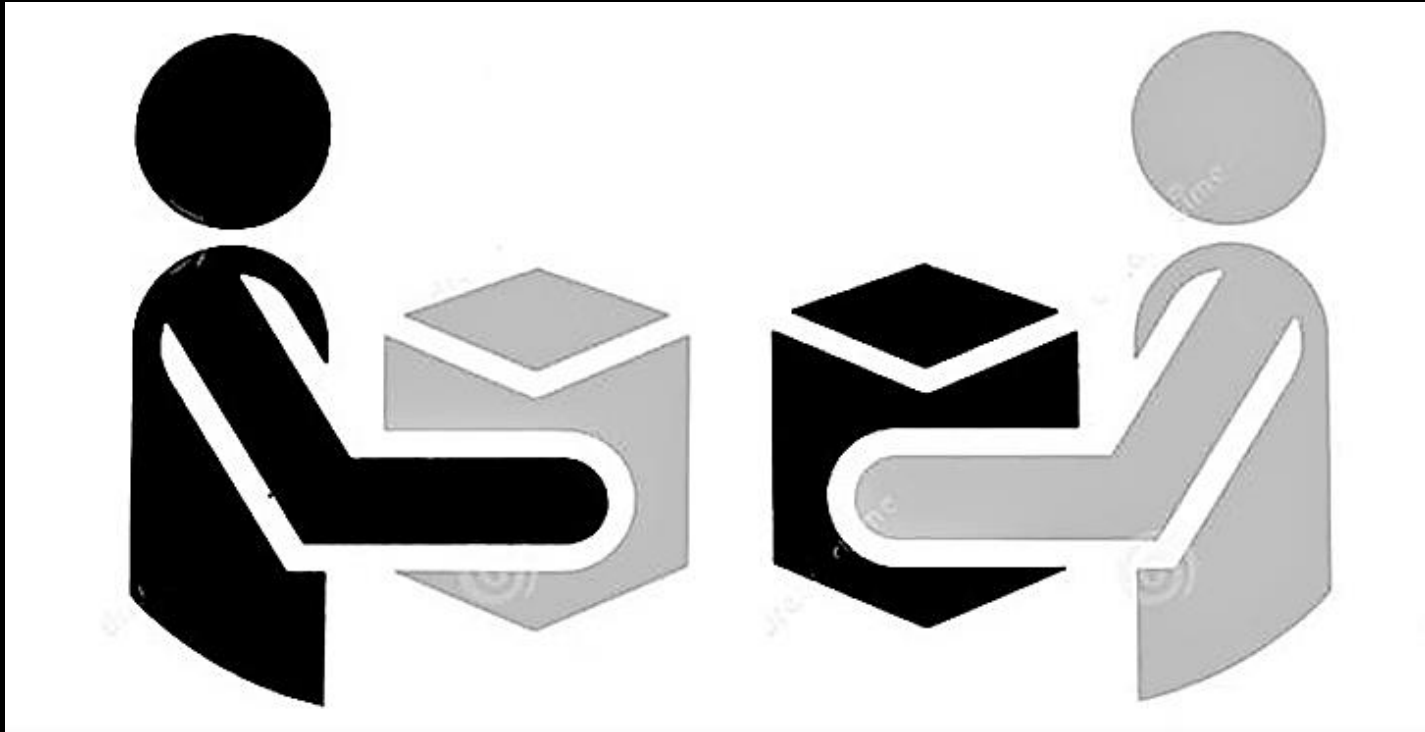

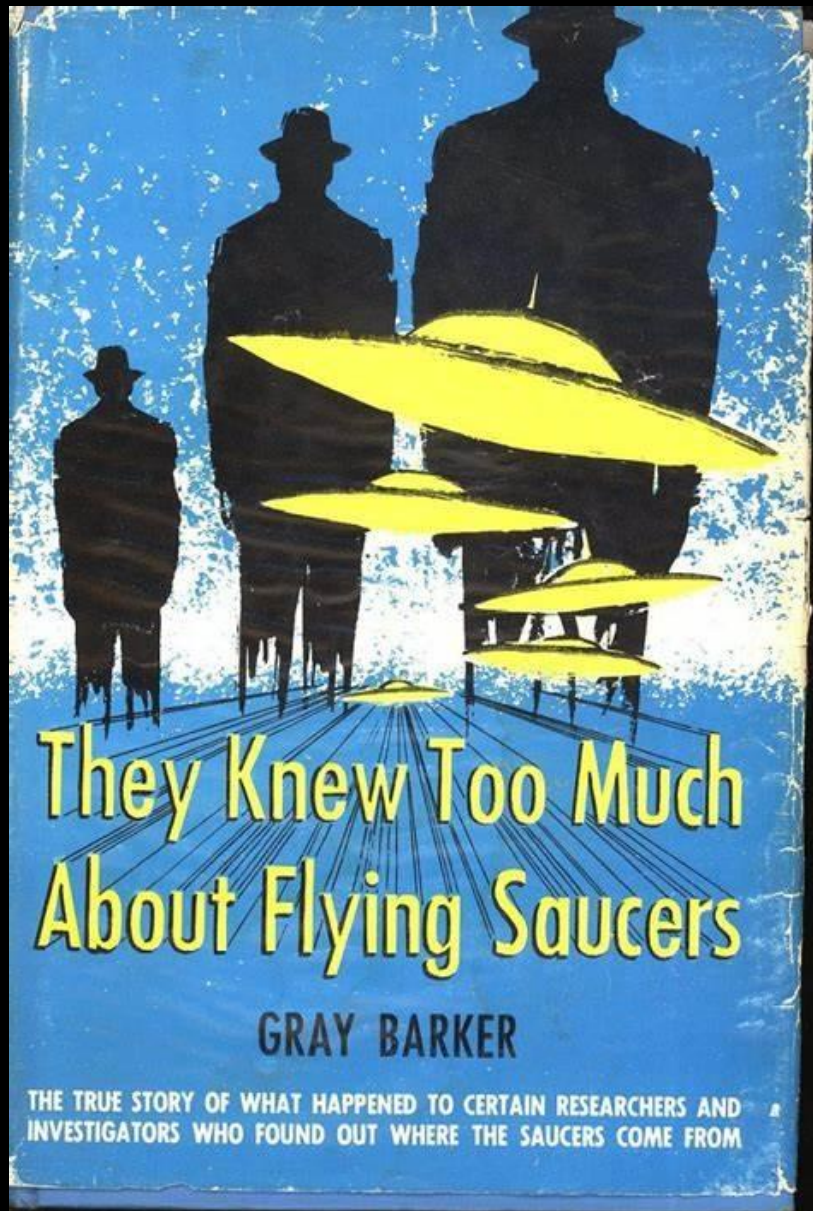
In 1978 after a base officer in retirement went public, more eyewitnesses were willing to come forth

Shortly after that he was on his way to the grocery store when he was approached by two men in black suits who came out of a black Lincoln Town Car who told him not to say or publish anything.

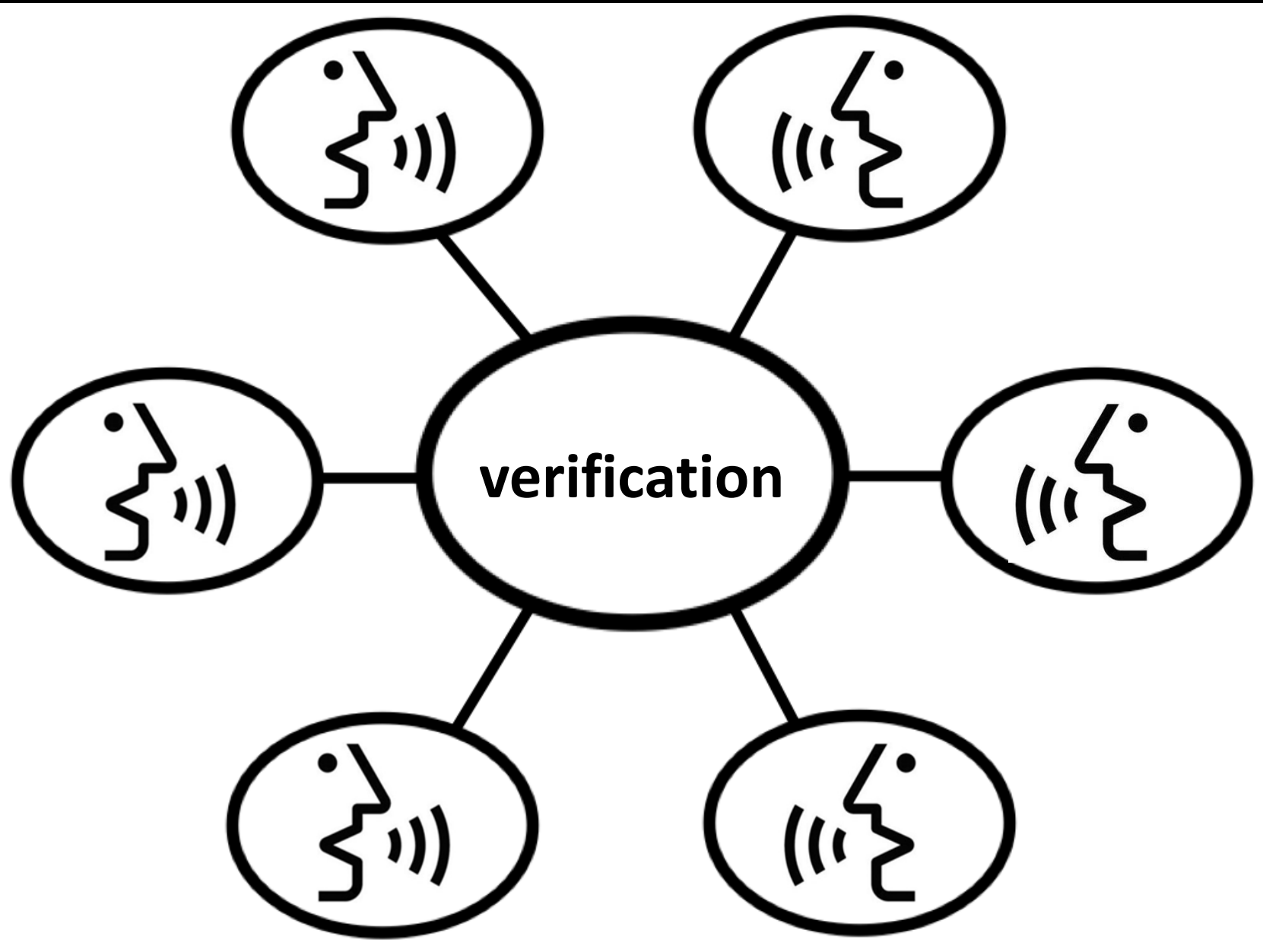


“They Knew Too Much”

Shag Harbour UFO Crash

1967, A small fishing village Shag in Canada an UFO was seen CRASHING into the water. The impact of the crash was so loud that it was heard within 3miles radius

Washington D.C

National airport spotted 7 objects on his radar at Mid Night 19th July 1952.
radar calculated the speed of objects to be 7000 miles/hour

Rendlesham Forest, Great Britain

United States Air Force several servicemen went to check a bright glowing metallic object which had landed, one of the servicemen touched its surface and noted down the symbols imprinted on the craft. The UFO moved slowly into the sky and went away.

Aurora, Texas, 1897

people claimed of an unknown airship crash resulting in the death of an individuality that was not human being.

The crashed plane was dumped into a well on the land while the 'alien' was buried acc. to christian rites.

1957: Astronaut Gordon Cooper Witnesses UFO Landing at Edwards AFB

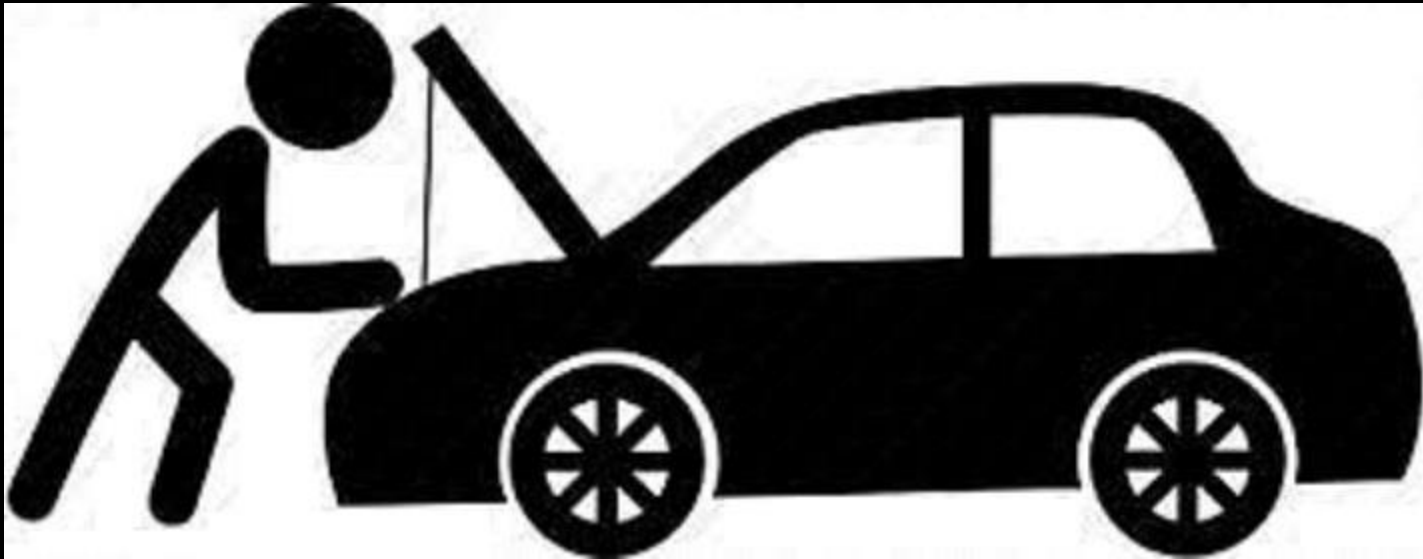
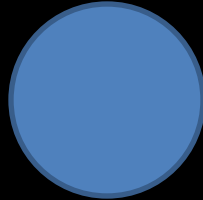

The FAA declined to investigate the incident because the UFO was not seen on radar and called it a "weather phenomenon"



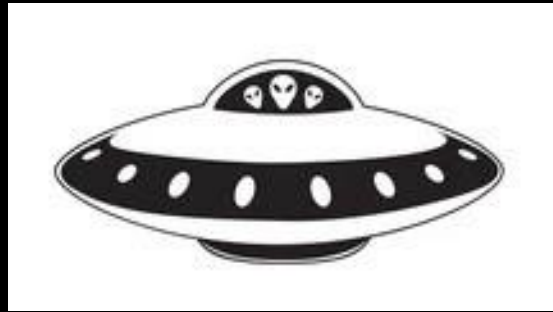
